SAMARITAN COLLEGE OVERVIEW

Samaritan College is an innovative initiative for the provision of R-12 Catholic education in Whyalla, operating as a single entity, allowing the College to create contemporary educational opportunities for the 21st Century. Established in 2008 through the amalgamation of St Teresa's School, Our Lady Help of Christians School and Saint John's College, it offers quality co-educational learning programs for students from Reception to Year 12. Samaritan College welcomes students and families from all backgrounds and cultures.

Providing a Christian education in the Catholic tradition, Samaritan College takes its name from the Samaritan Gospel stories and its ethos is centred on the values which are at the heart of the parable of the Good Samaritan (Luke 10:25-37) and the encounter of Jesus with the Samaritan Woman (John 4:1-42) at Jacob's well.

The College's motto - *Faith, Wisdom, Compassion*, reflects the values and qualities that are at the heart of the Samaritan gospel stories.

Samaritan College is currently situated on three campuses:

St Teresa's Campus (R-Year 6)

Darling Terrace

Our Lady Help of Christians Campus (R-Year 6)

Toal Street

Saint John's Campus (Years 7-12)

Gowrie Avenue



HISTORY

Samaritan College values its traditions and the many Whyalla families who have contributed significantly to the Catholic education story for over 60 years. The history of each of the founding schools is briefly captured below.

Our Lady Help of Christians School (formerly R-7) was founded by the Sisters of the Good Samaritan in February 1966 and commenced with an enrolment of 94 students. Located in Toal Street, Whyalla Stuart, Our Lady Help of Christians has been offering a quality Catholic education to the families of Whyalla for more than four decades.

St Teresa's School (formerly R-7) was established in January 1942 by the Catholic community of St Teresa's Parish by the Sisters of the Good Samaritan at the invitation of Bishop McCabe, Catholic Diocese of Port Pirie, with an enrolment of 99 students. Located in Darling Terrace, St Teresa's School has been offering a quality education in the Catholic tradition from Reception to Year 7 to the families of Whyalla from more than three generations.

Saint John's College (formerly 8-12) was established by the Catholic community of Whyalla and opened as a boys' school in February 1963, conducted by the Christian Brothers. It became a co-educational school in partnership with the Sisters of the Good Samaritan when it amalgamated with St Francis Xavier Girls' School in 1975. Saint John's College has been offering a quality comprehensive co-educational secondary education in the Catholic tradition from Year 8 to Year 12.

In March 2007, following community consultation, Bishop Hurley announced that the new Reception to Year 12 College would take its name from the Gospel Samaritan stories and would be called Samaritan College.

In 2017, the college moved its Year 7 classes to the secondary campus, thereby creating two R-6 campuses and a 7-12 campus.





OUR LOGO

Designed by Burton Nesbitt Graphic Designers, the Samaritan College Logo embodies the theology, spirituality and community values expressed in the Samaritan Gospel stories. It highlights the importance of the Catholic faith that underpins all our endeavours, emphasising the notion of compassion, selflessness and the benefits of wisdom through our own experiences.

The logo's composition shows a pair of hands cupped together in a chalice-like structure reminiscent of the Samaritan Woman's water jar and is also shaped to appear as birds in flight. The birds present the notion of joy and hope in a caring and nurturing environment. They suggest youthfulness and a positive uplifting perspective. The main bird in the centre of the composition is comfortably nestled within this cradle like shape. The cross, also an emerging element, is surrounded by the living water of Jacob's well, representing faith in action.

The symbolism here encompasses not only the notion of the Good Samaritan providing care and compassion to those in need, but also the union of the three schools as one, which ties in with the concept of the Holy Trinity, projecting a sense of support, nurture and encouragement within its bounds.

The central bird with irregular and outstretched wings suggests a welcoming environment and can also be viewed as emerging and taking flight. The wings embrace the cross emerging out of the living water - for at the heart of it all are the Christian values of the community.

The bird's closed eye gives the impression of peace, calm, tranquillity and freedom, underpinned by a sense of support and security. The fresh, open structure makes for a positive, uplifting impression that helps to project a sense of hope and aspiration.

PARISH AND GOVERNANCE

Samaritan College is situated in the Catholic Parish of Whyalla.

The Governing Authority of Samaritan College is the Catholic Diocese of Port Pirie Inc and is governed by the College Board constituted according to *Catholic Education South Australia's Manual for School Board Members, 2005*. The Board members are updated at the Annual General Meeting each year. The composition of the Board is set out below:

Members are coopted to the Board from time to time. The following Sub-Committees have been established to deal with specific tasks.

- Uniform
- Finance
- Parents and Friends

The Board is a clear sign of partnership between parish and school, parents and staff, and in particular, between the school and the broader Church community. Membership of the Board reflects the diversity of the school community and the different voices, experiences and perspectives that support the Catholic ethos of the College.

CURRICULUM

The curriculum of Samaritan College can be described as the sum total of all teaching and learning activities in our school. It aims to develop in children a range of capabilities that enable them to understand and engage in a changing world and play an active part in it.

At Samaritan College, learning is focused on student centred teaching methods, the interconnectedness of knowledge and the importance of communication in all its forms.

We believe that each child has enormous potential to learn and develop. This means that we provide approaches to teaching and learning that take into account the different ways children learn. Much of our practice involves “hands on” tasks that allow children to understand and process their learning.

Excellent resources ensure that teachers have the materials and equipment they need to create an interesting and interactive program. Information/Communication technology is integrated into all curriculum areas.

Teachers across all three campuses of Samaritan College attend regular Learning Team Meetings to ensure that their knowledge of contemporary methods is not only current but oriented towards the future. Teachers plan learning programs together to provide consistency in learning content and in approaches presented to students.

Like all Australian schools, Samaritan College follows the Australian Curriculum.

Reception - Year 6 Curriculum

The knowledge, skills, attitudes and values, which the curriculum aims to develop in children include:

- effective communication
- reasoning logically and thinking critically
- a positive sense of self and the ability to cooperate with others
- expressing oneself through arts, crafts and sport
- learning constantly and adapting to continual change
- applying information
- investigating and solving a wide range of problems
- understanding one’s culture as well as those of others

Years 7 - 12 Curriculum

Students attending Saint John's Campus are given the opportunity to select subjects from a broad and comprehensive curriculum which provides a foundation in both academic and vocational pathways.

In Years 7, 8 & 9 students continue studies in the nine key learning areas that have a focus on developing a sound foundation for studies at senior secondary level and the achievement of the SACE.

Students who have a particular interest in a trade in industries such as engineering or building and construction also have the option in Year 11 to undertake TAFE or VET subjects or pursue school-based apprenticeships through our flexible learning program.

In addition, students at Saint John's Campus have an opportunity to participate in a wide range of sporting and co-curricular activities including inter-school sports carnivals, the College Musical and the Samaritan Spectacular.

A strong focus on community outreach and citizenship is evident in programs from Reception to Year 12. Cross campus interaction is encouraged through organised events and inter-class activities.

Student Leadership

From Reception to Year 12, personal responsibility and student leadership is encouraged through informal and formal activities. The College recognises that we are a community of learners, thus it seeks to foster the development of leadership skills of interaction and teamwork, through the Student Representative Council and subsequent student committees.

Religious Education

At the heart of the College curriculum is the Religious Education Program which centres on the experience of children growing within a Catholic community.

Religious Education is an integral part of our school program and the classroom is one place among many in the Catholic school where students are invited into an encounter with the beliefs, values, rituals, codes, texts, faith and the community of the Catholic Church. Religious Education is a part of our whole day - incorporated into the life of the College as well as in the classroom. Social action initiatives teach young people the importance of community outreach and local and global responsibility.

We believe that the College assists the work of parents/caregivers as the primary educators of their children and at Samaritan College we recognise the role played by parents and parish in the faith development process.

We believe that Religious Education is complemented in many ways by the other key learning areas including the senior secondary curriculum offerings of the College.

The Catholic tradition is the primary point of focus for Religious Education and it has its foundation in the life, death and resurrection of Jesus Christ.

The Religious Education Program is based on sound curriculum and learning principles and is developmental and sequential from Reception to Year 12. It takes into account the Church Liturgical Year and local, College, Diocesan and community events. The teaching centres on an awareness of God in us, others, the world and in our faith community. South Australian Catholic Schools following the Crossways Religious Education Framework.



The Religious Education Program aims to develop in all students:

Knowledge, understanding and appreciation of:

- Christian beliefs about God
- the person and message of Jesus
- the dignity of the human person
- the experience and function of prayer and liturgy
- the purpose and structure of the Christian community
- the application of freedom and responsibility
- the structure of prayer and Scripture
- the acceptance of the challenge to follow Jesus.

At Samaritan College students participate in Prayer, Mass and Liturgies as part of the Religious Education Program. Retreats are a particular feature of the Religious Education program for secondary students.

Students from other Christian traditions and other world religions attend our school. Our school's Religious Education program integrates the faithful teachings of the Catholic tradition with sensitivity to what can be shared by all students.

The College works closely with the Parish team and we are an integral part of Parish life with children attending Liturgies held at either the Whyalla Parish Mass Centres or at the College. Our close relationship with the Catholic Parish of Whyalla is particularly evident through the Sacramental Program which prepares students for the Sacraments of Reconciliation, Eucharist and Confirmation in their primary years.

Social Justice teaching, learning and action is evident in the College through a range of outreach programs including: Project Compassion, Catholic Missions, St Vincent de Paul Society and various local charities.

Made in the Image of God

"The creator says to each of us: 'Before I formed you in the womb, I knew you' (Jer 1:5). We were conceived in the heart of God, and for this reason' each of us is a thought of God. Each of us is willed, each of us is loved, each of us is necessary.' (Pope Francis, 2013)

What is Made in the Image of God? (MITIOG)

The Made In The Image Of God (MITIOG) Human Sexuality Curriculum is designed for students who attend Catholic schools in South Australia from Years R-12. This curriculum is grounded in the Catholic belief that human beings are made in God's image and likeness.

It celebrates the Catholic Church's teaching centring on the dignity of the human person and as such honours the individual's worth and their right to experience respectful and healthy relationships. It is an inclusive curriculum which acknowledges and respects the uniqueness of each person's inherent goodness.

The MITIOG curriculum has been developed to ensure that human sexuality education is accessible to all students in Catholic schools, and that it is delivered in an age appropriate and culturally sensitive manner. It is respectful of an individual's right to make healthy and informed choices about their bodies and their relationships.

Catholic understanding is that all humans are made in the image of God and therefore deserving of the utmost dignity and honour, and that our sexuality is a fundamental dimension of the human person. We acknowledge that the beliefs, values and insights of the Christian Tradition and Catholic moral teaching enrich our lives.



The Made in the Image of God curriculum provides students with knowledge and strategies to explore the themes of:

Identity, Relationships, Human Development, Reproduction and Reproductive Health

The MITIOG curriculum supports teachers in CESA schools to provide quality, contemporary and pastoral human sexuality education. CESA teachers, as educators in faith, are supported through

comprehensive professional learning and training to lead and facilitate teaching and learning of the MITIOG curriculum.

Some elements of the MITIOG curriculum can be taught in conjunction with the Government of SA, Keeping Safe Child Protection Curriculum and the ACARA Health and PE (R-10) curriculum.

ENROLMENT

The Samaritan College community welcomes the enrolment of students from Reception to Year 12 from all families who are seeking excellence in education within a Catholic school.

Samaritan College offers a Catholic education to all who are willing to support the ethos of a Catholic school and who seek an education according to the conditions contained within our enrolment contract. In offering enrolment, we undertake to provide opportunities for families to enter into a partnership, focussed on providing a safe and nurturing environment in which children can learn and develop spiritually, socially, emotionally, physically and intellectually within the Catholic tradition.

Samaritan College undertakes to support parents/caregivers in passing on Christian beliefs and practices based on the Catholic tradition. We endeavour to provide an excellent, comprehensive education which encourages students to develop skills, acquire knowledge, and to actively participate in, and contribute to their local community and wider society.

Primary Enrolments

At Samaritan College students enrolled in Reception to Year 6 classes will be based at either Our Lady Help of Christians Campus or at St Teresa's Campus.

Parents/caregivers are able to nominate the primary campus of their choice. The Principal, however, reserves the right to determine the placement of primary students which will be largely dependent on factors relating to the enrolment numbers at each site.

Enrolments at the primary campuses will be considered according to the South Australian Commission for Catholic Schools' policy on admission and progression of students.



Secondary Enrolments

As Samaritan College is one entity, all children enrolled in the primary campuses do not need to complete another **enrolment form**, but simply submit the **transition form** indicating an intention to continue their schooling at Samaritan College. Thus Year 6 students already enrolled at Samaritan College are guaranteed their place.

Opportunities for Year 6s to become comfortable with secondary campus life include; participation in the secondary Patrons Day, combined Masses, Transition Days and curriculum visits with their teacher.

All students from other schools will need to complete the enrolment application and attend a family interview with the Principal or Deputy Principal or the Head of Campus.

Transition information evenings and Principal's Tours in Term 2 and Term 3, provide useful information and prepare all students for a seamless transition to secondary schooling.

The Term 4 Orientation Tours and Transition Days provide further opportunities to develop confidence in students as they become more familiar with the campus. The stepped transition process from Terms 2-4 assists students to adjust in a period of significant change.

Enrolment Procedure

Families with a commitment to Catholic education and its ethos are invited to apply for enrolment at Samaritan College through:

1. Enquiries made at one of the Samaritan College campuses or through the website on www.samaritan.catholic.edu.au
2. On receipt of the Enrolment Information package, which includes an Application for Enrolment form, privacy policy and other information, parents/caregivers are asked to return the completed Application for Enrolment form to the Campus Administration Office.
3. Upon receipt of the completed form the applicant's name will be added to the list of applicants seeking entry to the College in the year and at the level designated.
4. Places of enrolment are offered by the Principal according to criteria found on the following page.
5. Interviews will be conducted by a Principal/Deputy Principal and will include discussion about the student's and family's needs, the ethos of Samaritan College as well as financial and support expectations.
6. Formal offers of enrolment will normally be made prior to the date of commencement. Acceptance of such offers will involve a contractual agreement being signed between the parent/caregiver and the school.
7. A letter will be sent to the parents/caregivers advising them of the starting date, transition meetings and any other information relating to the student's commencement at the College.
8. If a place is not available and the application meets the enrolment criteria, the student will be placed on the waiting list. Parents/caregivers will be notified if a place becomes available.
9. It is the responsibility of parents/caregivers to advise the College of changes to address and/or contact details. Failure to do so may preclude an applicant from offers of enrolment.
10. The following must accompany an Application for Enrolment Form
 - Copy of Birth Certificate
 - Most Recent School Report (for non-reception enrolments)
 - Any relevant medical, behavioural and psychological assessments

Process of Enrolment for Students with Special Needs (Physical, Medical, Emotional, Intellectual, Visual, Hearing)

Samaritan College will follow the processes for enrolling students with special needs as stated by the South Australian Commission for Catholic Schools. Please note this process requires additional procedures to those listed above. Please contact the Registrar for further information.

Enrolment Criteria

The criteria listed below will guide the Principal to determine the eligibility of students for enrolment at Samaritan College and will be used in developing a priority for enrolment, when demand for positions exceeds enrolment places available. The date of lodging an Enrolment Application will also be used as a guide in determining an offer of enrolment place.

1. Catholic children whose parents live in the Catholic Parish of Whyalla and whose parents have a commitment to the parish and the practice of their faith.
2. Children who have a sibling currently enrolled at Samaritan College.
3. Children of Old Scholars, including the former Our Lady Help of Christians School, Saint John's College and St Teresa's School.
4. Children who are transferring from another Catholic school.
5. Catholic children, whose parents do not practice their faith, but indicate a willingness to renew their interest and wish to educate their children in the Catholic faith.
6. Non-Catholic children whose parents have a commitment to their own faith, and are open to their child's faith development in a Catholic school environment.



Basis of Enrolment Discretion

- The Principal of Samaritan College reserves the right of discretion in accepting any enrolment which includes determining the campus at which the student is located in the primary years.
- Suitability of placement for children with special needs is to be determined in consultation with the CESA Special Education consultant, prior to an offer of an enrolment place being made.
- In special circumstances, the Principal will consider an application for early entry in consultation with the family and the teachers concerned, and on the basis of access to various assessments, reports and information.

Additional Enrolment Criteria for Students Commencing in Reception

- The criteria for starting Reception on the first day of school in Term 1 is that the child will attain the age of 5 on or before April 30 in that year.
- The criteria for starting Reception on the first day of school in Term 3 is that the child will have attained the age of 5 on or before October 31 in that year.
- Children starting in Reception in Term 3 will have 6 terms in Reception.
- Children whose 5th birthday falls between November 1 and December 31 are not eligible to commence school before the following year.

Note: *Reception students who start mid-year pay no fees at all for that year.*

TUITION FEES

Contributions made by families towards their children's education are an integral component of the overall funding received by the College. Commonwealth and State funding contribute around 75% of overall income that Samaritan College relies on to operate efficiently.

As a matter of equity among families that attend the College, there is an expectation by the College Board that the complete sum of fees payable on behalf of each student is completely paid within the school year.

Parents and guardians agree at the time of enrolment that they will be responsible for their children's fees while at the College. There is an expectation that this commitment will be honoured.

Payment of Fees

All new families are required to enter into a direct debit agreement. Accounts for existing families can be paid by cash, EFTPOS, cheque, direct debit, credit card, internet transfer and salary or Centrelink deductions. All current families that do not meet their agreed payment option commitment will be required to enter into a direct debit agreement.

Fees may be paid weekly, fortnightly, monthly, termly or as a single lump sum. All fees are to be paid by November of the current school year. Accounts are to be paid in full within 30 days of the invoice if a Payment Method Form is not completed.

Standard Fee Schedule

The 2024 tuition fee for R is \$1,800, 1-7 is \$2,800, 8-9 is \$3,800 and 10-12 is \$4,800. Tuition fees cover the cost of stationery at primary campuses, certain year level camps at all campuses and secondary retreats.

Reductions are provided for 2nd and 3rd children. All 4th and subsequent children attending the College are free. Fee calculations are to be determined from the highest year level to the lowest.

The school Fees are set in reference to the College's Fee Policy found on our website which in turn is governed by the Fees Policy of the South Australian Commission for Catholic Schools, also available online or by request.

Financial Assistance

Families on low incomes are encouraged to apply each year for assistance. There are 2 types of assistance available.

- Families not eligible for the School Card who are suffering genuine financial hardship are encouraged to submit a *Financial Assistance Application* found on the School's website at www.samaritan.catholic.edu.au or collect a hard copy at the School. All applications will be assessed on an individual basis.
- Families eligible under the *School Card Scheme* are requested to submit a School Card application as early as possible. It is important that parents/caregivers work with the school to complete the necessary documentation. Families eligible and approved for School Card will receive a 75% reduction on their tuition fees as detailed in the table below. Income threshold details can be obtained from the Bursar or at <https://www.sa.gov.au/topics/education-and-learning/financial-help-scholarships-and-grants/school-card-scheme>.
- Income thresholds for single child families in 2025 are \$74,189. Thresholds increase dependant on the number of children attending school.

UNIFORM

The wearing of the College uniform is compulsory at Samaritan College. Students are expected to wear their uniform with pride and to be well groomed at all times. The school uniform is stylish and of good quality as well as being practical, hardwearing and economical. The College values the multi-purpose nature of uniform: it creates equity; considers safety; engenders pride and a sense of identity; prepares young people for the world of work and creates affordability for families. We do expect students to adhere to the uniform expectations and for parents to follow the age guidelines for uniform change.

Samaritan College has a sun-smart policy which provides opportunity for young people to make responsible health care decisions with regard to minimising risk from sun damage. All students are expected to wear the uniform wide-brimmed hat during Terms 1, 3 and 4 when engaged in outdoor activity. The cut and style of the uniform takes into consideration sun protective factors and the use of sunblock is encouraged during outdoor activities. Other WHS elements of the uniform are lace-up closed shoes (secondary) and activity appropriate sports shoes. Reception to Year 2 students can wear velcrose fastenings in accordance with their developmental stage.

STUDENT ACCIDENT INSURANCE

All students attending Samaritan College that sustain any injuries as the result of an accident that occurs at school or on a school organised activity, are covered under the Catholic Education Student Accident insurance policy.

Insurance cover includes payments for medical services where that service is not already covered by Medicare. Depending on the type of injury, a lump sum payment may also be provided.

It is important to note that the policy only covers ACCIDENTS. If an ambulance is called for a health-related issue (seizure, anaphylactic, diabetes etc), the ambulance is not covered under this policy. Families of children with pre-existing conditions should always be encouraged to hold their own ambulance insurance.

To make a claim you can access the claim form [here](#) and complete all sections up to Page 5. The forms can then be forwarded to your campus Administration with copies of relevant medical reports. The college will complete the remainder of the form and submit on your behalf.

RELEASE OF INFORMATION AND PRIVACY INFORMATION

6. From time to time, Samaritan College may be required to communicate to parents that personal information has been requested by the Commonwealth and State Governments and the Catholic Education Office
7. Samaritan College may disclose personal information (your name and address) to another Catholic school who may wish to provide you with information to assist you in choosing another Catholic school.
8. Personal Information collected from students is regularly disclosed to their parents or guardians.
9. In situations where parents are separated, it is the policy of the college to release school reports to the mother and father of the student upon request. It is also our policy to allow both mother and father to attend parent/teacher interviews upon request. However, the college will abide by any court orders which prevent the release of such information.
10. Samaritan College may store personal information in the 'cloud' which may mean that it resides on servers which are situated outside Australia.
11. In the event of default of payment of fees, Samaritan College may refer the default to a debt collection agency. If this occurs, personal information will be disclosed to the agency and you will be responsible for the collection costs.
12. Samaritan College's Privacy Policy sets out how parents or students may seek access to personal information collected about them. However, there will be occasions when access is denied. Such occasions would include where access would have an unreasonable impact on the privacy of others, where access may result in a breach of the School's duty of care to the student, or where students have provided information in confidence. Any refusal will be notified in writing with reasons if appropriate

13. The college's Privacy Policy also sets out how you may complain about a breach of privacy and how Samaritan College will deal with such a complaint.
14. Samaritan College may engage in fundraising activities. Information received from you may be used to make an appeal to you. It may be disclosed to organisations that assist in the college's fundraising activities solely for that purpose. We will not disclose your personal information to third parties for their own marketing purposes without your consent.
15. On occasions information such as academic and sporting achievements, student activities and similar news is published in college publications and online platforms (including website and facebook). Photographs of student activities such as sporting events, school camps and school excursions may be taken for publication in college publications and online platforms. The college obtains permission in the first year of the student's enrolment which covers their school life at Samaritan College. Should you wish to change those permissions, this must be done by completing a replacement Photograph/Video/Artwork Consent Form.
16. We may include students' and students' parents' contact details in a class list and School directory.
17. If you provide Samaritan College with the personal information of others, such as doctors or emergency contacts, we encourage you to inform them that you are disclosing that information to the college and why, that they can access that information if they wish and that the college does not usually disclose the information to third parties.
